**Note: The above fees are without the use of the Concession Stand. If the Concession Stand is used there will be an additional charge of \$25.00.**

### **Security Deposit**

A security deposit, in the amount of \$50.00, is required from all renters. Security deposit will be refunded if Center is in good, clean, undamaged condition.

**Funerals** -- There will be no use fee charge, however, a security deposit will be required.

Terms and Conditions

1. Use fee \$\_\_\_\_\_ and security deposit of \$50.00 will be made prior to use of Center.
2. I / we agree that no equipment or furniture will be removed at any time from the building.
3. I / we agree that all utensils and kitchenware will be cleaned and returned to appropriate area.
4. Renters are responsible for their own set up and take down for their events including but not limited to tables and chairs, as well as sweeping floor, bagging and placing all trash in the outside dumpster.
5. Alcoholic beverages and any form of drugs or narcotics are not permitted on Tribal Property. The Tribal Drug-Free Workplace policy will be followed and enforced.
6. The Fitness Center is a Smoke-Free Environment (per Tribal Policy). There is no smoking permitted inside the Center.
7. Renter agrees to provide at least 1 adult chaperone for every 10 juveniles, when renting for the purpose of juvenile activity, further agree that said juveniles will not be permitted to go "in and out" of the building until conclusion of that function.
8. Renter agrees to not allow unauthorized person(s) in the Center. (Any person not a member of the above organization or group).
9. No pets/animals are allowed.

**Security and Cleaning Deposit:** A Deposit of \$50 is required for all rentals at the Fitness Center. Renters are responsible for reasonable care of the facility and furnishings, cleanliness and security of the key. Costs incurred as a result of rental, including loss of the key or unsatisfactory cleaning after the rental will be deducted from the Deposit. If the cost of such damage or loss exceeds the \$50 Deposit the renter will remain liable for the balance. Any portion of the deposit due to the renter will be returned upon satisfaction of all requirements, including return of the key.

I have read the terms and conditions regarding rental and use of the Fitness Center. I agree to comply with these terms and conditions, and to inform individuals present at my rented use of the Fitness Center of these terms and conditions.

I further agree to be responsible for any damage or loss and shall hold harmless and indemnify the Klamath Tribes, its officers, agents, and employees from any and all liability for personal injury, death or property damage arising out of my use of the facility.

**Violation of any of the above-mentioned terms, may result in immediate removal from premises and possibly, denial of future use of the Center.**
