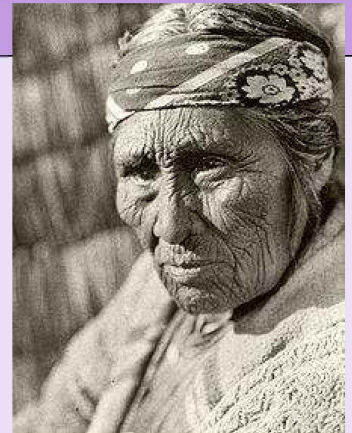

ENERGY ASSISTANCE PROGRAMS

Energy Assistance Coordinator (541) 783-2219, ext. 186 for:

- Elders EA – Payments for electricity, natural gas, propane, firewood, etc. Must be a Klamath Tribal Elder (60+) & no income limits (Dependent on when/or if funding is available)
- ❖ LIHEAP – Payments for your electricity, natural gas, propane, firewood, etc. for low-income households (\$250 to \$600)
- ❖ Home Weatherization, repairs, or replacement of windows, doors, floors, roof, insulation, appliances, stoves, etc. (max \$3,500/three years)



SUPPLEMENTAL ASSISTANCE PROGRAMS

Commodities Warehouse (541) 883-2876:

- ❖ Food Distribution - Large Food Packages (delivery offered) to Elders (60+), disabled, & or homebound Individuals.

Administrative Assistant (541) 783-2219, ext. 174 for:

- ❖ Goodwill Vouchers for clothes, shoes, housewares, etc. (\$20 to \$80)
- Employee Sponsored Emergency Fund (max \$100/year)
