

Questions and Answers

- 1. Can you confirm if an electronic/email submission alone is acceptable or is a paper submission required?
 - a. Yes, an email submission is acceptable. D.3. of RFP lists email instructions.
- 2. Current total number of Employees?
 - a. **200-300**
- 3. How often are employees paid?
 - a. Bi-Weekly
- 4. What is the current Operating Expense Budget? Can you provide copy of the latest budget document?
 - a. \$650,000 \$700,000 OR \$325,000 per payroll cycle
- 5. Does the Klamath Tribes have a PEO? (Manage our Federal Taxes under "your" company tax umbrella?)
 - a. The Klamath Tribes files/pays for their own taxes
- 6. What is The Klamath Tribes SUTA rates or Oregon O.Q.?
 - a. 2024 SUTA rate is 2.1%
- 7. What company is the current Workers Compensation through?
 - a. Tribal First
- 8. Given the need to provide Position Budgeting functionality, would The Klamath Tribes consider implementing a solution that also includes an integrated suite of Financials applications? (Single ERP solution across Finance, Payroll, and Timekeeping)
 - a. Currently the Klamath Tribes operates off the systems MIP and MICROX and is in search of a solution that can either integrate and add with the current systems or implementation of a new suite of applications. As the Klamath Tribes has increased in size and revenue the current system does not provide the full confidential capabilities the various programs require when sharing information. This RFP is the start to The Klamath Tribes deciding how to best move forward.
